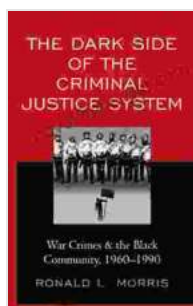

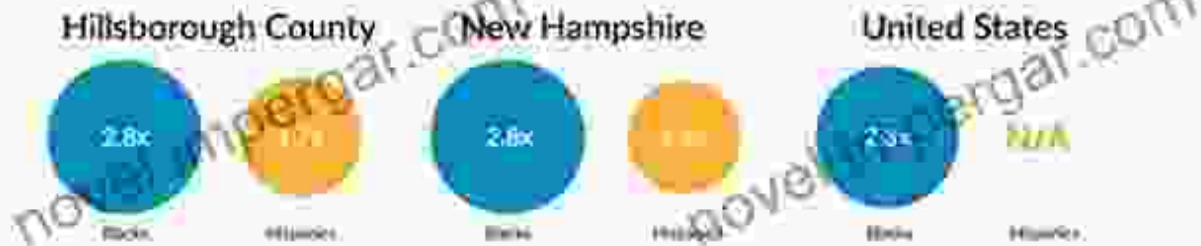

LIKELIHOOD OF BEING ARRESTED COMPARED TO WHITES



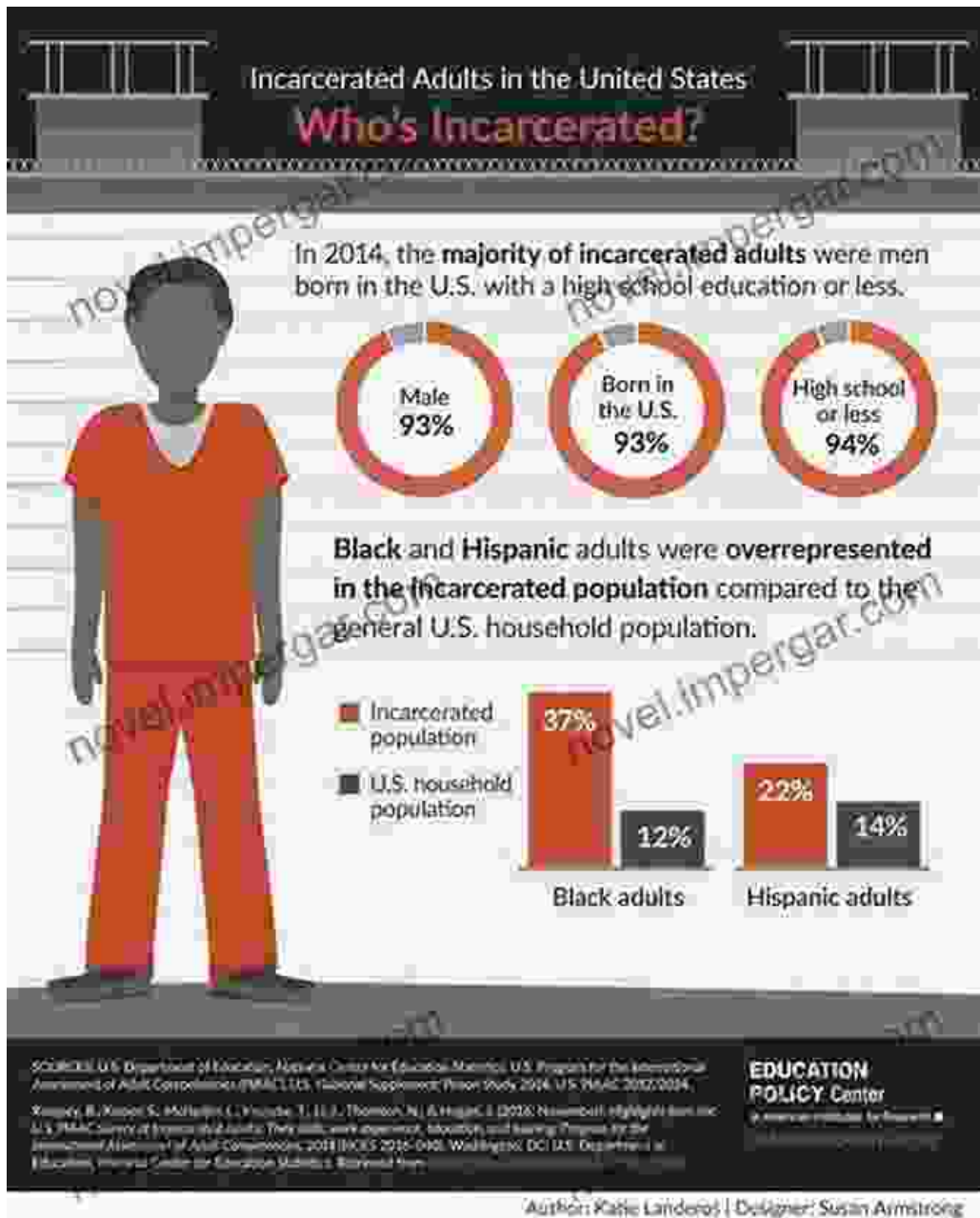
LIKELIHOOD OF BEING IN JAIL COMPARED TO WHITES

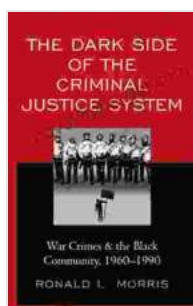

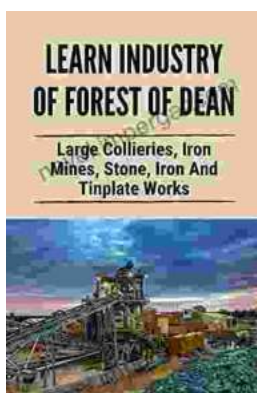

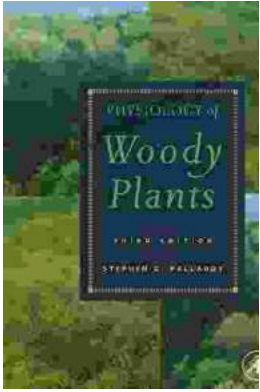
